- 01. Qualification: Post Graduate Degree (MD/MS/DNB, Diploma) in the concerned disciplines from a recognised university/institution. Must not have completed 03 years Senior Residency in any recognized institutions including regular and adhoc basis.
- 02. Pay scale: Pay Rs. 67700/- as per 7<sup>th</sup> CPC Level 11 plus allowances as admissibale under the rule.
- 03. Age limit: 45 years for GEN, 5 years relaxable for SC/ST and 3 years for OBC candidates (belonging to Delhi only). On closging date of submission of application.

## 04. DMC Registration Certificate.

**Tenure:**- The appointment will be initially for 89 days or till joining of regular Senior Resident whichever is earlier. That can be extended further up to a maximum period of 03 years subject to satisfactory performance, work and conduct report from concerned HOD.
