Eligibility:

Post Graduate Degree/ Diploma from recognized University/Institutions & should be enrolled with Delhi Medical Council.

Age Limit:-

45 years for General (5 years relaxable for SC/ST, 3 years relaxable for OBC and 5 years extra relaxable for Persons with disabilities (Divyangjan) candidate as on date of interview.

Fee Payable :-

Rs.500/- for General/OBC Candidates in the form of Demand Draft/Pay order in the favour of DDO, Attar Sain Jain Eye & General Hospital payable at Delhi. SC/ST candidates are exempted from payment of fee.

Tenure:-

The tenure of senior residents is for a period of 3 years including any service rendered as senior residents earlier on adhoc/regular basis in any recognized institution. The appointment will be initially for 1 year or on prorate basis that can be extended further upto a maximum period of 3 years subject to satisfactory work and conduct report from concerned incharge and vigilance clearance.

Emoluments: Pay Matrix of Level 11 (Rs 67700-208700) other usual allowances as admissible under the rules.

1. Candidates must have a valid DMC Registration Certificate.

The number of vacant posts may vary.

SC/ ST certificates issued from Judicial/ Revenue Authorities and OBC Certificates issued from Govt. of Delhi shall only be accepted. Further reservation to Handicapped candidates shall be given as per Rules.

In case of Non- availability of candidates under SC/ ST/ OBC Category, vacancies may be filled

up from the General category and Vice Versa on Ad-hoc Basis.

List of eligible candidates shall be displayed on the website of H&FW Department. No separate call letters shall be sent and no TA/DA shall be admissible for attending interview.

Candidates are required to bring all original certificates and testimonials along with two recent passport size photographs on the date of interview.

Appointment shall be subject to medical fitness and verification of certificates.

8. The applicant under relaxed eligibility criteria as per instructions contained in circular no. F. 121/26/2010/H&FW/1996-2045 dated 10.06.2011 of Health & Family Welfare may apply i.e. who have completed three years of Senior Residency and one year of Junior Residency. However, they will be appointed only in case of non availability of fresh eligible candidates and a separate list will be prepared for them.

9. In case of SR, in the specialties where no fresh candidates are available, the candidates who have completed three years Senior Residency but are willing to serve as Sr. Resident can also apply. However their appointment will be for a period of 89 days extendable up to a maximum period of

one year only.

10. In case of SR, Separate merit lists for fresh candidates and for other (those who have completed 3 years of senior residency already) would be prepared.

- 11. Submission of application:- Interesest candidates may report for registration at 9:30 AM till 11:30 Am in the establishment branch with application form along with Demand Draft, photocopies of qualifying certificates, date of birth proof, Photo ID card and address proof. Only those candidates whose registration is completed by 11:30 AM shall be eligible for appearing before interview board. The interviews will be held thereafter. All original certificates must be brought for verification.
- 12. The decision of the Medical Superintendent will be final. In case of any dispute the Jurisdiction of Court will be Delhi/ New Delhi.
