Minimum Academic/professional Qualification, age limit, emoluments, tenure etc, for appointment of Sr. Residents/Jr. Residents (MBBS & Dental) are as under:-

For Sr. Residents:-

- 1. Post graduate Degree/Diploma from recognized university/institution
- 2. In case of non-availability of P.G degree/ diploma, the candidates having MBBS degree with minimum 02 years of work experience in Govt. Hospital (out of which one year (approximately) should be in the speciality concerned) may be considered.

For Jr. Residents (MBBS):-

- MBBS from recognized university/institution.
- Internship completion certificate, internship not more than 02 years old as on date of Interview i.e on 28.09.2021.

For Jr. Residents (Dental):-

- BDS/MDS from recognized university/institution.
- Internship completion certificate, internship not more than 02 years old as on date of Interview i.e on 29.09.2021.

AGE LIMIT:

For Sr. Residents :- 45 years for General, 48 years for OBC [belonging to Delhi only] and 50 years for SC/ST candidates as on date of interview.

For Jr. Residents(MBBS & Dental): - 30 years for General category 33 years for OBC [belonging to Delhi only] and 35 years for SC/ST candidates as on date of interview.

There would be no extension for any senior resident beyond one year appointed under this relaxed Provision.

Jr. Residents (MBBS):-

- Upper age limit for eligibility under relaxation will be 40 years.
- 2. Post Graduate doctors who are interested to serve as Junior Residents will be allowed to join as Junior Resident, if fresh graduate are not available.
- 3. Junior Residents who have completed one year of Junior Residency may be allowed to again appear for interview for selection and will be offered residency only if no fresh Junior Residents are available. There would be no extension for any junior resident beyond one year appointed under this relaxed provisions.

TENURE OF RESIDENCY:-

For Sr. Residents

ON ADHOC BASIS: - initially appointed for a period of 89 days OR till regular appointment is made by the Government under any scheme or proposal, whichever is earlier. In case of no regular appointment of Sr. Residents/Specialists is made by the government, the tenure can be further extended for a further period of 89 days (with one day compulsory break) time to time for a maximum period of 03 years OR till regular appointment of Sr. Residents/Specialists is made by the Government under any scheme or proposal, whichever is earlier.

For Jr. Residents (MBBS & Dental):-

ON ADHOC BASIS: - initially appointed for a period of 89 days OR till regular appointment is made by the Government under any scheme or proposal, whichever is earlier. In case of no regular appointment of Jr. Residents (MBBS & Dental) is made by the government, the tenure can be further extended for a further period of 89 days (with one day compulsory break) time to time for a maximum period of One year (which will be count from the date of joining of the candidate) OR till regular appointment of Jr. Resident (MBBS & Dental) is made by the Government under any scheme or proposal, whichever is earlier.

Note: - if any candidate has served/worked as a Sr. /Jr. Resident, either on regular basis OR on adhoc basis, in any Govt. Hospital/Institution earlier, the residency period will be deducted/adjusted from/in the tenure of selected Sr. /Jr. Resident.

EMOLUMENTS:

For Sr. Residents: - As per 7th CPC pay matrix level 11, Pay Rs. 67700/- plus usual allowances as admissible under the rules.

For Jr. Residents (MBBS & Dental):- As per 7th CPC pay matrix level 10, Pay Rs. 56100/-plus usual allowances as admissible under the rules.

Other eligibility norms/General Conditions/Requirements:-

- Registration with Delhi Medical Council /Delhi Dental Council is compulsory as on date of interview.
- 2. The posts will be filled up in phases as per availability of vacancies and as per need of the department. The number of vacancies as shown above may subject to change in any stage.
- 3. Appointment shall be subject to medical fitness and verification of educational Certificates.
- 4. Candidates applied under the OBC category, must have valid OBC certificate at the time of interview, issued from the Competent Authority of GNCT of Delhi. OBCs certificates of other states (except Delhi) will not be accepted. The OBC certificate should be issued during the current financial year.
- Candidates applied under EWS category, must have valid EWS certificate (issued during the current financial year) at the time of interview, issued from the Competent Authority.
- 6. No TA/DA will be paid for appearing in the interview.
- 7. In case of non availability of SC, ST and OBC candidates, as the case may be, the posts shall be filled from General Category Candidates and vice versa.

- 9. The selected candidate can be posted in any Jail of Delhi Prisons as per requirement i.e in Tihar. Rohini and Mandoli.

Resident Medical Officer Central Jail Hospital Tinar, New Delhi-114-21 panel of wait listed candidates will be prepared and if any vacancies arising in future, the same will be filled from the panel. The Panel shall be valid for 06 months from date of publication of result of the interview OR till fresh selection process is carried out, whichever is earlier.
