- 01. Qualification: MBBS with Post Graduate Degree (MD/MS/DNB, Diploma) in the concerned disciplines from a recognized university/ institution. Must not have completed 03 years Senior Residency in any recognized institution including regular and ad-hoc basis.
- 02. Pay Scale: Pay Rs. 67700/- as per 7th CPC level 11 plus allowances as admissible under the rules.
 - 03. **Age limit:** 45 years for GEN, 5 years relax able for SC/ST and 3 years for OBC candidates (belonging to Delhi only) on closing date of submission of application.
