#### Note:

1. For candidates applying for OBC category, the certificate must be issued by the competent authority of GNCT of Delhi.

2. Reservation to various categories for post will be as per Government Guidelines

issued from time to time.

3. In case of Non Availability of reserved candidates, the vacant post shall be filled up for 89 days on adhoc basis from the panel of selected candidates under UR category.

4. The number of vacancies may vary.

#### **ELIGIBILITY:**

### A. EDUCATIONAL QUALIFICATION

(1) MBBS Degree from recognized University. Foreign Graduates must have cleared FMG examination. (2) Internship completion certificate and (3) Must be registered with Delhi Medical Council on last date of submission of application form. Acknowledgment slip of DMC registration will not be accepted. (4) Must not have completed one year Junior Residency in any recognized institution. Preference will be given to candidates who have completed internship not before two years of advertisement.

## B. AGE LIMIT

30 years for Junior Residents as on last date of Submission of advertisement, 05 years age relaxation is allowed for SC/ST and 03 years for OBC candidates with certificate issued by Government of National Capital Territory of Delhi only will be considered.

## C. EMOLUMENTS:

Pay scale Rs.15600-39100 plus Grade Pay Rs.5400/- per month plus other allowances as admissible.

# D. FEE PAYABLE FOR THE POST OF JUNIOR RESIDENT:

Rs. 300/- for General & OBC candidates in the form of Demand Draft issued in favour of "Director, Guru Nanak Eye Center, New Delhi" payable at New Delhi. (Non refundable). SC/ST Candidates are exempted from payment of fees.

# OTHER TERMS AND CONDITIONS FOR ENGAGEMENT

- (a) The appointment will be initially for 6 months extendable upto one year, subject to satisfactory performance and work and conduct. The service conditions will be regulated as laid down in the residency scheme. Appointment will be subject to Medical Fitness / verification of Testimonials & Character & Antecedents report.
- (b) Service will be governed under residency scheme and inter hospital transfer is not permissible, however appointing authority reserves the right to transfer services Junior Resident within the Hospital.
- (c) Schedule of selection process:
  - Last Date of submission of application completed in all aspect will be 04-09-2021 by 12.00 Noon
  - Display of eligible candidates for appearing in selection process will be 07-09-2021 at 03:00 PM
  - The interview for Junior Resident Non-PG will be conducted on 14-09-2021 from 10:00 AM onwards.
- (d) The applicants for Junior Resident post should reach the venue on time on the given date of interview with all original and attested copies of certificates. Failure to bring any documents the candidates shall not be allowed to appear in the interview / written test.
