Pay Scale: Pay Rs. 67700/- as per 7th CPC level11 plus allowances as admissible under the rules.

Age: 40 years for General, 5 years relaxable for SC/ST and 03 years for OBC candidates (belonging to Delhi only) on the closing date of submission of application.

Tenure: The tenure of Senior Residents is for a period of three years including any service rendered as Senior Resident earlier on adhoc / regular basis in any recognized institution.
