A. Qualification:-

- (1). MBBS with Post Graduate Degree/ DNB/ Diploma or equivalent as per residency scheme in concerned specialty from a recognized University/ Institution.
- (2). In the condition, if candidates having P.G. degree/DNB/Diploma are not available, those without P.G. qualification but having 02 years experience in concerned speciality may be considered.
- B. Age: Below 37 years, On Date of Interview, as per order No.F.DHF&W/Q015/57/2016-HR-Medical-secy(H&FW)/CDNo.112425062/2413-18 dated 04/10/2018. Age limit is relaxable by 05 year for SC/ST candidates.
- C. Pay:- Basic of RS. 67700/- in pay Matrix 11 of 7th CPC with other allowances as admissible per month.
- <u>D.</u> The candidate must have completed internship.
- E. Must be registered with Delhi Medical Council.
