ELIGIBILITY CRITERIA FOR THE POST OF JUNIOR RESIDENT [MBBS]:-

- 1. Qualifications:-MBBS degree from recognized University/Institute. Candidate must have not completed one year Junior Residency from any Govt. Hospital including(adhoc/regular).
- 2. Age Limit As on 21.12.2020 shall be 30 years for General candidates, 35 years in case of SC/ST and 33 years in case of OBC candidates (OBC certificate issued from Delhi only).In case fresh candidates are not available, in accordance of circular No. F.No.121/26/2010/H&FW/1996-2045, dated 10.06.2011 issued by Health & Family Welfare Department, Govt. of NCT of Delhi the age limit shall be 40 yrs.
- 3. Pay Scale:-Pay Matrix 10 of 7th CPC with Basic Pay of Rs. 56100 and other admissible allowances per
- 4. Internship:-Candidates must have completed their internship on or before 21/12/2020 and the candidates having completed compulsory rotatory internship before 21/12/2018 shall not be eligible.
- 5. Must be registered with Delhi Medical Council.
- 6. Appointment will be initially for a period of 6 months extendable up to maximum of one year on the basis of satisfactory work & conduct report from the concerned HOD on request from the doctor
- 7. Appointment will be subject to medical fitness and verification of certificates of educational qualification/age/caste/DMC registration and internship completion certificate etc.
