Note : One post is reserved for Physically Handicapped person as horizontal reservation of SR.

- OBC certificate issued from Govt. of NCT of Delhi shall only be accepted.
- In case of non-availability of SC/ST/OBC/EWS candidates, the post may be filled from General categories.

Qualification : MBBS with post graduate Degree / Diploma/DNB in the concerned specialty from a recognized University / Institution and should have a valid registration with Delhi Medical Council and the candidate must not have completed 03 years Senior Residency in any recognized institution including regular and ad-hoc period. In case of non availability of PG candidates, minimum 03 years experience in concerned specialty may be considered as per residency scheme and will be appointed on adhoc basis..

Pay scale: Rs. 67700 – 208700 of level 11 plus allowances as admissible under the rules.

Age: 45 years for Gen. and OBC candidate and age relaxation for SC/ST candidate as per rule.

Other conditions of Recruitment :-

1. The tenure of Regular Senior Residents shall initially be for a period of one year which is extendable up to a maximum period of three years **subject to good performance work and conduct report from concerned HOD** (including the previous experience as Senior Resident on adhoc or regular basis from any recognized institutions)
2. The candidates who are already in Govt. Service should submit an NOC from his / her employer.
3. The services shall be governed by residency schemes of Govt. of India / Civil Services (Temporary Rules).
4. Candidates are required to bring all original certificates and testimonials with their attested photocopies along with one passport size photograph on the date of interview.
5. Candidates who are working on adhoc basis in JPCH shall have to apply afresh.
6. Appointment shall be subject to medical fitness and verification of certificates.
7. The number of vacancies may vary.
8. In case of non-availability of SC/ST/OBC candidates, the post may be filled on Adhoc Basis from other categories and vice-versa.
9. OBC candidates are required to submit their certificate by the competent authority of Govt. of NCT of Delhi.
