- Applicant should possess a valid degree from a recognized institution and should be registered with Delhi Dental Council.
- The candidate should have completed compulsory rotatory internship and should not be more than of 2 years pass out.
- Those who have done one year Junior Residency will not be eligible, however, if fresh candidates are not available, those who have completed one year of Junior Residency shall also be allowed to appear in the interview and will be offered residency for a further period of six months or as decided by the Health & FW Department from time-to-time.
- Reservation to differently abled candidates will be allowed as per rules.

**AGE LIMIT:-**


- 30 years for Junior Residents as on 01.01.2021.  
(Age relaxation is allowed for SC/ST and OBC/PH candidates as per rules.)
