ELIGIBILITY

- a) For JR: MBBS from recognized university,/Institute
- b) **INTERNSHIP:** Must have completed internship after 01/08/2020.

Must be registered with Delhi Medical Council

- c) **EMOLUMENTS:**

For JR Rs. 56,100/- plus usual allowance as admissible under the rules.

- d) **AGE LIMIT:**

Age below 30 year as on 30/6/2021 Relax able for SC/ST by 05 years and for OBC by 03 years (OBC candidates are required to submit their caste certificate issued by the Competent Authority of Govt. of NCT of Delhi).(*) Further in case of non availability of candidate, as per the relevant scheme mentioned above candidates may be considered in terms of relaxation of provisions as per circular No. F. No. 121/26/2010/H&FW/1996-2045 dated 10.6.2011 issued by Health and Family Welfare Deptt. GNCT of Delhi with the following relaxation:

- (a) PG Doctors who are interested to serve as JR will be allowed to join as Junior Resident if fresh graduates are not available, upper age limit in such case will be 40 years of age.
- (b) Candidates must have not completed one year Jr. Residency from any Govt. Hospital (*)
- (*) Second list: Jr. Residents who have completed one year of Jr. Residency shall also be allowed to appear in the interview and will be offered residency only if fresh Jr. Residents are not available. There would be no extension for any Jr. Resident beyond one year of appointment.

TENURE:

Appointment will be initially for a period of 89 days extendable on the basis of satisfactory work and conduct report from the concerned in charge and written request from the Doctor concerned.


CONDITION FOR RECRUITMENT:

- A. All the eligible candidates should report in the office of the undersigned at 9.30 A.M (time for enrollment from 9.30 A.M to 10.30 A.M only) on the day of interview.
- B. For candidate applying for OBC category the certificate must be issued by the Competent Authority of Govt. of NCT of Delhi. Persons with disabilities shall be given relaxation as per rule.
- C. The number of vacancies may vary.
- D. No TA/DA will be given for appearing in the interview.
- E. Candidate may submit their Bio Data with attested photocopy of certificates and original documents should be shown at the time of interview. They shall also up load their resume with necessary documents on hospital web site dncjmh2020@gmail.com. Candidates are advised to ensure that they fulfill the eligibility criteria as mentioned in the advertisement before appearing the interview.
- F. Other service conditions will be applicable as per service conditions prescribed from time-to-time by the Govt. of NCT of Delhi.
- G. Candidate who is already in Govt. Service Should submit No Objection Certificate from the employer at the time of interview.
- H. Jurisdiction of Dispute in case of any legal dispute the jurisdiction of court will be Delhi/New Delhi.
