Registration will be done from 10 A.M. to 11 A.M in room no. 126 (Admin Branch) only and Interview will be conducted after 12.00 Noon as per schedule above.

ELIGIBILITY

For Non PG SR: MBBS, should be registered with Delhi Medical Council and minimum 02 years experience in the field of Medicine/ICU/Casualty.

EMOLUMENTS

For SR: Pay Level-11 (Rs.67700-208700/-) + plus usual allowance as admissible under the rules.

AGE LIMIT: Below 45 years as on date of interview. The age relaxation is applicable up to 05 years for SC & ST and 03 years for OBC candidates (Non Creamy layer belonging to Delhi only).

RECRUITMENT CONDITIONS:

1. Other service conditions as prescribed from time to time by the Hospital will be applicable.
2. Seats will be reserved for differently abled candidates as per the prevailing Govt. rules.
3. A panel of wait listed candidates will be prepared for filling the post of SR for vacancies arising in future.
4. The decision of the Selection Board/Medical Superintendent of AAA Hospital regarding selection will be final and binding and no representation will be entertained in this regard.
5. The appointment and services will be governed under the Residency Scheme. Total tenure of a senior resident will be maximums of three years which will also include any senior residency tenure done in other govt. /govt. funded institution. Appointment will be initially for a period of 89 days extendable up to maximum of three years on the basis of satisfactory work & conduct report from the concerned HOD and written request from the SR concerned.
6. The contract of appointment can be terminated by either party by giving a notice of 07 days without assigning any reason.
7. All appointment shall be subject to medical fitness and verification of certificate of educational qualification/age/caste/submission of valid DMC post graduation registration certificate etc.
8. If any declaration/information furnished by the candidates are found to be false or any material/fact is suppressed willfully, the candidature/appointment will be cancelled/terminated



- forthwith and due Administrative action/legal action will be taken. Delhi Medical Council will also be intimated for initiating appropriate action.
9. Bring all Original Documents along with self attested Photocopies on the schedule date of Interview.
 10. No Correspondence or personal enquiries shall be entertained.
 11. No TA/DA will be paid for the Interview.
