**Qualification:** MBBS degree from a recognized University, valid registration with Delhi Medical Council is required. Must not have completed one year Junior Residency in any recognized institution including regular & adhoc period.

**Pay scale:** Rs.56100 – 177500 of level 10 plus allowances as admissible under the rules.

**Age:** 30 years for Gen, 35 years for SC/ST and 33 years for OBC candidates on the closing date of submission of application.
