Qualification: MBBS degree from a recognized University. Valid registration with Delhi Medical Council. Must not have completed one year Junior Residency in any recognized institution including regular & adhoc period.

Pay scale: Rs.56100 – 177500 of level 10 plus allowances as admissible under the rules.


Age: 30 years for Gen, 35 years for SC/ST and 33 years for OBC candidates on the closing date of submission of application.

In case of any legal dispute the jurisdiction of court will be Delhi/New Delhi only.


