1. No registration after 10.00 A.M. will be considered.
2. OBC certificate (along with current year Non Creamy Layer ) issued by GNCTD only shall be considered.
3. Candidates must have a DMC Certificate with Validity at the time of interview.
4. Applicant who have completed 1 year Junior residency earlier in any Medical Institutions will also be considered in case of non-availability of fresh candidates on Adhoc basis for 89 days or till the regular candidate is appointed whichever is earlier . Fresh candidates are those who have not done Junior Residency or have completed less than one year residency.
5. Candidate must have completed one year rotatory internship /passed FMG examination on or after 13.01.2022 ( i.e. 2 year before date of interview
6. The services of Junior Resident shall be governed by residency schemes of GOI and orders issued by H&FW Deptt., GNCTD.
7. Appointment will be subject to medical fitness and verification of certificate of educational qualification /age/caste/EWS/DMC registration and internship completion certificate etc.
