Separate merit lists for fresh candidates and for other (those who have completed 3 years of senior residency already) would be prepared. If no fresh candidates appear/joins, the candidates who have completed 03 years of Senior Residency will be considered.
4. The appointment will be for a period of 89 days extendable upto maximum of 3 years after 01 day break of each tenure of 89 days or till the regular candidate joins, which ever is earlier.
5. The appointment will be extended on the basis of satisfactory work and conduct report from concerned HOD and request from the resident doctors concerned.
6. Appointment will be subject to medical fitness and verification of certificate of educational qualification /age/caste/EWS/DMC registration and internship completion certificate etc.
