Requirements

1. **AGE LIMIT:** 45 years (relaxable for 05 years for SC/ST & 03 years for OBC candidates)

2. **DMC Registration:**

A) Candidates must have a valid DMC registration certificate of MBBS (Delhi) along with registration of their PG Degree/MD/Diploma with DMC or "Applied for receipt of there PC Degree/diploma/DMC on the date of interview.

B) Those candidates who have applied for PG/Degree/Diploma in DMC, if selected will be appointed on Adhoc basis for 44 days, they should submit valid DMC certificate of PG within 44 days from the date of joining otherwise there candidature will be terminated after 44 days.

C) Those candidates who applied with 02 years' experience post MBBS should have valid DMC certificate of MBBS (Delhi)

3. **EMOLUMENTS:** Level 11 of pay matrix with basic pay Rs. 67700/- plus applicable DA,NPA,HRA,TPT.

Terms & conditions:-

1. No registration after 10.00 A.M. will be considered.
2. The services of Senior Resident shall be governed by residency schemes of GOI and orders issued by H&FW Deptt., GNCTD.
3. In case of non-availability of fresh candidates, the candidates who have completed 3 years of Senior Residency may also be allowed to appear in the interview. Separate merit list will be prepared. In case the list of fresh candidates gets exhausted, then the candidates with 3 years of Senior residency in respective department will be given preference & will be appointed on Adhoc basis for 89 days (Max upto 01 year) or till the regular candidates joins.
4. In case of SC/ST/OBC Certificate reveals that the claim to belong to these categories is fake/false the services will be terminated forthwith without assigning any further reason & without prejudice to such further action may be taken under the provisions of Indian Penal Code for production of fake/false certificate.
5. In case of non-availability of SC/ST/OBC category, vacancies may be filled up from the General Category Candidates for 89 days on Adhoc basis (or till regular candidate joins in respective category whichever is earlier).
6. Appointment will be subject to medical fitness and verification of certificate of educational qualification /age/caste/EWS/DMC registration and internship completion certificate etc.
