2. ELIGIBILITY CRITERIA FOR THE POST OF SENIOR RESIDENTS

A. Qualification:-

- (1). MBBS with Post Graduate Degree/ DNB/ Diploma or equivalent as per residency scheme in concerned specialty from a recognized University/ Institution.
- (2). In the condition, if candidates having P.G. degree/DNB/Diploma are not available, those without P.G. qualification but having 02 year's experience in concerned specialty may be considered on adhoc basis (till the PG or regular candidate joins, whichever is earlier).
- B. Age: Below 45 years, On Date of Interview, as per order No.F.DHF&W/Q015/57/2016-HR-Medical-secy(H&FW)/CDNo.112425062/1502-08 dated 26.11.2020. Age limit is relaxable by 05 year for SC/ST candidates.
- C. <u>Pay:</u>- Basic of RS. 67700/- in pay Matrix 11 of 7th CPC with other allowances as admissible per month.
- **D.** The candidate must have completed internship.
- E. Must be registered with Delhi Medical Council.
- **F.** Appointment will be initially for a period of 89 days or till regular joins or till the specialist joins, whichever is earlier and may be extended beyond 89 days maximum upto 03 years on the same conditions based on work and conduct report.

- 4. Further, all senior Resident appointment from second list will be for one year only for those who have already completed 3 years of Residency. It would not be renewable after one year. Senior Resident may be assigned duties in Emergency Department as & when required in case of any exigency.
