(For Supply of Medicines – Jan Aushadhi drugs)

Accordingly, Jan Aushadhi Kendras / Authorized Retailers of Delhi registered under PMBI are invited to submit their quotations for the supply of the required medicines at rates not exceeding the MRP fixed by PMBI.

Interested vendors may submit their quotations via email <u>at purchasejpch@gmail.com</u> to the undersigned within two (02) days of publication of this notice.

The list of medicines along with the terms and conditions for the supply are enclosed herewith for ready reference.

The hospital reserves the right to accept or reject any quotation without assigning any reason thereof.

Terms and conditions

- 1. Each item should be clearly marked as "Hospital Supply Only Not for Sale. By permanent ink"
- 2. Supply should be made strictly in accordance with the approved specifications/sample.
- 3. A penalty @5% per week (maximum 25%) shall be imposed in case the supply is not made within the stipulated time period, i.e., maximum 5 days' time.
- 4. The supplier should possess a valid drug licence as per the Drugs & Cosmetics Rules, 1945 (wherever applicable) at the time of placing the order & supplying the items.
- 5. The shelf life of the supplied items should not be less than three-fourths (¾) of the total shelf life at the time
- 6. Supply of items should be in accordance with Circular No. F.No.01/SSH&FW/06/2022/532-536 dated 15/03/2024 of the Vigilance Branch, H&FW Department, GNCTD (if applicable). Further, the concerned storekeeper is advised to ensure that the price of the received items is not higher than the MRP for the same.
- 7. Regarding lab reports, PMBI has to submit that all drugs are NABL tested and sourced from WHO-GMP certified manufacturers, with compliance printed on each strip and product packaging. Therefore, routine submission of separate lab test reports is not feasible or required at the store level.
- 8. The concerned I/c store is advised to take action as per the extant guidelines/orders and the request letter submitted by JAK. Other codal formalities should be followed as mentioned in the circular dated 15/03/2024 of the H&FW Department, GNCTD.
- 9. The supplier must not supply drugs from blacklisted/debarred firms (as per the list available on https://janaushadhi.gov.in). The concerned store is directed to cross-check on the Jan Aushadhi website that the supply is from authentic sources only.

The supplier must also submit an undertaking along with the supply mentioning that:

- A) All the drugs/medicines are genuine and as per supply from PMBI (Govt. agency).
- B) All the medicines are tested by a Govt. agency (test report received from PMBI).
- C) All supplies are from genuine, authentic firms/manufacturers and no firm is debarred/blacklisted.
- D) All supplies are as per Govt.-approved rates and PMBI/the firm has not supplied the same medicines/drugs
- E) No discount is applicable/available as per PMBI guidelines for supply to any institute/hospital, and PMBI/JAK
- F) If any stock remains unconsumed within its shelf life, it should be replaced with fresh stock by the supplier. is not offering discounts on MRP to anyone.
- 10. The concerned store should check all supplies and documents before receiving them.
