Applications are invited to fill up the 02 posts of **Senior Residents** on **regular basis** for which **interview will be held on 03/11/2017**. The numbers of posts indicated above are provisional and subject to change without any notice. The details of vacancies are as under :-

**Reservations:** Genl.1 SC 1

**Eligibility:**

- 1. Qualifications** Post Graduate Degree/Diploma from a recognized university enrolled with Delhi Medical Council.  
The candidate must not have completed three years Sr. Residency in any hospital under State Govt./Govt. of India including regular and ad-hoc period. In case of non-availability of PG candidates, minimum 03 years experience in concerned specialty may be considered as per residency scheme.
- 2. Age Limit** 33 years for General (5 year relax able for SC/ST, 3 years relax able for OBC and 5 years extra relax able for physical handicapped candidates as on 01.09.2017) For candidates applying for OBC category, the certificate may be issued by the Competent Authority of Govt. of NCT of Delhi only.
- 3. Emoluments** As per pay matrix of Level-11 (Rs. 67,700-2,08,700) plus usual allowances as admissible under the rules.
- 4. Tenure** Appointment will be initially for a period of 1 year extendable maximum up to 3 years on the basis of satisfactory work and conduct report from the concerned In charge and written request from the Doctor concerned.
- 5. Terms & Conditions:**
  - i. **Candidates must have a valid updated DMC Registration Certificate** (Delhi Medical Council Act, 1997 dated 11.02.1997).

ii. In case of non-availability of fresh candidates, enabling provisions shall apply as per Govt. of India rules (Circular F.No. 121/26/2010/H&FW/DSHFW/1996-2045 dated 10.06.2011) with the following relaxation:-

1. Upper age limit for eligibility for SR will be 40 years.
  2. In case of non availability of fresh candidates, the candidates who have completed 3 years of senior residency may also be allowed to appear in the interview as fresh candidates.
  3. Separate merit list would be prepared for the candidates who have completed their residency of 3 years as SR.
  4. Firstly, the list containing the names of the fresh candidates would be exhausted for the appointment and the second list would be used only after that.
  5. Further, all senior residents appointments from 2<sup>nd</sup> list will be for a maximum period of 1 year only.
- iii. Candidates who are already in Govt. service should submit NOC from the employer.
- iv. No TA/DA will be paid for attending the interview.
- v. Candidates are advised to ensure that they fulfill the eligibility criteria as mentioned in the advertisement before appearing in interview.
- vi. Other service conditions will be applicable as per the service condition prescribed from time to time by the Govt. of NCT of Delhi.
- vii. The decision of the Selection Board regarding selection will be final and binding and no representation will be entertained in this regard.
- viii. The services of SRs will be governed by the residency scheme of Govt. of India/ Civil Services (Temporary Rules).
- ix. All candidates are exempted from payment of fee.
- x. In case of Non-availability of candidate the post will be filled on adhoc basis from other categories.

**Interested candidates may submit their application form by 01/11/2017 before 4 P.M. along with photocopies of qualifying certificates, date of birth proof, photo ID card, caste certificate(if applicable) and address proof. Only those candidates who fulfill the criteria will be eligible for appearing before interview board. Their names will be displayed on official web site a day before the interview. The interviews will be held on 03/11/2017 at 10:30A.M. sharp and candidates have to report to the office of undersigned at 9.30 A.M. All original certificates must be brought for verification.**
