

### NOTICE FOR RECRUITMENT OF JUNIOR RESIDENT (DENTAL) ON REGULAR **BASIS**

Online applications are invited from Indian Nationals for the post of Junior Resident (Dental) under Residency Scheme in this hospital on Regular Basis for a period of six months extendable upto one year only, subject to the satisfactory work & conduct report from HOD/In-charge concerned, after completion of initial term of engagement of six months-

#### 2. MODE OF SELECTION

The selection will be made on Merit Basis through Screening Test only.

# 3. ELIGIBILITY FOR THE POST OF JUNIOR RESIDENT (DENTAL)

- A. Qualification: BDS degree from recognized university/institute. Must not have completed one year Junior Residency in any Govt. institute/hospital in India on Regular or Adhoc basis.
- B. Age: Maximum age 30 years as on date of screening test. Relaxation of age for OBC/PwD candidates will be given as per rule.
- C. Pay Scale: Basic of Rs. 56100/- in Pay Matrix 10 of 7th CPC plus other allowances as admissible.
- D. Internship: Must have completed internship after 20.08.2020.
- E. Registration: Candidates must have valid registration certificate of DCI/DDC/State Dental Council. Applications forms DCI/DDC/State Dental Council Registration Certificate or with 'Applied For' status shall not be considered.

#### **CONDITION OF RECRUITMENT**

- 1. The appointment and services will be governed under Residency Scheme & MoH&W, Govt. of India.
- 2. OBC certificate issued from Govt. of NCT of Delhi shall only be accepted.
- 3. OBC certificate from Govt. of NCT of Delhi should mention their belonging to Non Creamy Layer for this financial year.
- 4. Benefit of reservation will be granted only on the basis of caste certificate issued by the competent authority and production of original certificate
- 5. In case of OBC certificate reveals that the claim to belong to these categories is fake/false the services will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under the provisions of Indian Penal Code for production of fake/false certificate
- 6. Selected candidates shall be allowed to join within 07 working days from the issue of the offer letter failing which the offer shall stand automatically cancelled. No extension for joining will be considered.
- 7. All appointment shall be subject to medical fitness.
- 8. The service condition will be regulated as per the rules in the Residency Scheme, Ministry of Health & Family Welfare, Govt. of India of 1983.
- 9. No TA/DA & Accommodation for stay in Delhi will be paid/provided for appearing for written exam/interview.
- 10. The period for which a candidate has already worked in any Govt. Hospital as Junior Resident (Dental) will be deducted from the maximum period of one year of Junior Residency. Those who have already working for a period of one year in any govt. hospital are not eligible.
- 11. Persons with disabilities shall be given relaxation as per rules.
- 12. Original documents should be shown at the time of interview.
- 13. Candidates are advised to ensure that they fulfil the eligibility criteria as mentioned in the advertisement before applying.
- 14. Other service conditions will be applicable as per service conditions prescribed from time-to-time by the GNCTD.
- 15. In case of any inadvertent error detected at a later stage the same will be rectified as per rules.
- 16. Jurisdiction of Dispute- in case of any legal dispute the jurisdiction of court will be Delhi/New Delhi.
- 17. Competent Authority reserves right to decide in case of any dispute with regard to selection process.
- 18. Competent Authority reserves the right of any amendment or cancellation of the advertisement at any point of time.
- 19. The Competent Authority reserves the right to increase or decrease the seats.
