The engagement of retired doctors shall be governed as per terms & conditions mentioned in H&FW Deptt., GNCTD Circular No. F.JSHFW/2017/Plg./ssadminhfw/769-775 dated 13/10/2017 and Finance Department, GNCTD OM No. 20/4/2015-AC/204-248 dated 04/12/2015. Other terms & conditions are as under:

I. The engagement of retired doctors from Government Service as Consultant (Non-Teaching Specialist) on contract basis shall be against the vacant sanctioned posts of Specialist Grade-III (Non-teaching).

- The amount of monthly consolidated remuneration of retired doctors appointed as II. consultant shall be last pay minus basic pension plus DA at the applicable rate. However, a retired doctor appointed as consultant shall continue to draw pension and the dearness relief thereon during the period of their engagement as consultant. His/her engagement as consultant shall not be considered as a case of reemployment.
- The engagement / appointment to the post of Consultant shall take effect only after III. the candidate is found medically fit.
- In case the retired doctor resigns before the completion of tenure of one year, he/she IV. is required to give an advance notice of 15 days, failing which an amount equivalent to 15 days remuneration will be recovered from him/her without any prior notice.
- The retired doctor shall not be entitled to any benefit of provident fund, pension, V. gratuity, seniority, HRA, reimbursement of call charges of telephone/mobile, transport facility, LTC, etc. which is available to a government servant appointed on regular basis.
- VI. Neither any government vehicle nor any kind of conveyance allowance shall be provided to the consultants.
- VII. No TA/DA shall be admissible for joining the assignment and the consultant will not be allowed foreign travel at government expenses.
- VIII. The retired doctors will not be entitled for leave of any kind for study during the contract period.
 - The engagement of retired doctor as consultant against a vacant sanctioned posts, IX. would be on full-time basis and they would not be permitted to take up any assignment during the period of consultancy.
 - The engagement of consultant will be initially for a period of one year or till regular Х. appointment, whichever is earlier. However, it can be extended up to five (05) years or till attaining the maximum age limit of 70 years, subject to the satisfactory performance of the consultant and depending upon the specific job and the time frame. for its completion. In no case the extension would be allowed beyond five (05) years.
 - Consultants shall be eligible for 8 days leave in tenure of one year and they shall not XI. be paid remuneration in case they are absent beyond 8 days in tenure of one year. Further, un-availed leave in a tenure cannot be carried forward to the next tenure.
 - The engagement of consultants being purely on contract basis, will not bestow upon XII. him/her any claim for regular appointment.

Interested retired doctors must submit their application in the prescribed format as per Annexure-I in hard copy along with self-attested copies of following documents:-

- 1. Valid DMC Registration Certificate.
- 2. Undertaking regarding no vigilance case is pending at the time of retirement.
- 3. Educational Qualification Certificates.
