

PUBLIC NOTICE

In compliance with the order No. DH&FW/0015/52/2016/CD#112425062/4978-81 dated 28.07.2022 and order no.23.12.2022 issued by Dy. Secretary H&FW, that the "Walking-in-interviews may be conducted on Second and last Friday of every month for conducting interviews of Senior Resident doctors and Junior Resident Doctors in hospitals' for the regular/Adhoc appointment. Interested candidates should report at Administrative Block, Rao Tula Ram Memorial Hospital at 9.30 A.M. with original certificates of qualifications (Matriculation, Intermediate, MBBS and Master Degree), DMC registration, Identity proof & Experience Certificate etc. and one set of self attested photocopies of these entire documents along with two passport size photographs. The registration will close at 11.00 AM on the date of Interview. The details of Eligibility criteria are as under:

Eligibility Criteria for selection of Junior Resident Doctors.

MBBS degree from Recognized University & should be registered with DMC. For Junior Residency Internship should not have been completed more than 02 years on the date of interview.

Age Limit: 40 years, Age relaxation is allowed to eligible candidates as per Central Government Rules including for SC/ST/OBC etc. as per rule.

Eligibility Criteria for selection of Senior Resident Doctors.

MBBS with Post Graduate degree/Diploma from a Recognized University/Institution & should be Registered with Delhi Medical Council. In the event of non-availability of PG degree/diploma holder, MBBS with minimum 02 years post MBBS experience out of which 01 year should be in Government Hospital in the specialty concerned. However, the offer of appointment will be given on Adhoc Basis to a non PG candidate and would stand terminated during any time of tenure in the event of joining of a PG candidate. If suitable candidate is not found in any category, the seat will be filled by other category candidates purely on adhoc basis

Age Limit: For SR, below 45 years as on date of interview (age relaxation is allowed to eligible candidates as per Central Government Rules for SC/ST/OBC etc.)

NOTE:

1. OBC candidates with certificate issued only by Govt. of NCT of Delhi will be considered.
2. Candidates will only be entertained if actual Vacancy is available.
3. The salary and other T&C will be as per residency scheme as notified by the Government of NCT of Delhi from time to time. No TA/DA will be paid for appearing in the interview. Decision of the selection committee will be final.

Method of Exam: Oval Interview (Candidates scoring less than 50% will be considered as not qualified)
