Eligibility for Junior Resident (Dental):

- BDS degree recognition by Dental Council of India. Registered with Dental Council of India/Delhi Dental Council and have not completed 01 year Junior Residency (Dental) in any institution. Candidates, who have applied for the registration for the same, will not be considered.
- Candidates applying for the post of JR (Dental) must have completed their internship and only those candidates shall be considered for residency who have completed their internship within 02 year before the date of interview (completed not before 15.07.2019).
- Age limit is 30 years as on date of interview for General candidates, 35 years for SC/ST candidate and 33 years for OBC candidates on the date of interview. Further upper age limit for persons with disabilities shall be relaxable by 10 years.

Conditions of Recruitment:

- 1. Appointment will be initially for a period of 06 months extendable up to maximum of 01 year on the basis of work and conduct report from the concerned HOD.
- 2. Appointment will be subject to verification of certificate of Educational Qualification/Age/ registration and internship completion certificate.

3. OBC candidates are required to submit their caste certificate (issued before the date of application) issued by the Govt. of NCT of Delhi along with the Non Creamy Layer certificate of current financial year.

4. The services will be governed under Residency Scheme of Govt. of India

- 5. If any declaration/information furnished by the candidates is found false or any material/fact suppressed willfully, the candidate/appointment will be cancelled/terminated forthwith.
- 6. The decision of the selection board/medical Suptd. SVBPH regarding selection will be final and binding and no representation will be entertained in this regard.
- Selected candidates shall be allowed to join within 07 days of the issue of offer of Appointment failing which the offer shall stand automatically cancelled.
- 8. Candidates are advised to ensure that they fulfill the eligibility criteria as mentioned in the notice for Walk in Interview before appearing in the interview.
- 9. No TA/DA & Accommodation for stay in Delhi will be paid / provided for appearing for interview.
- 10. Pay Scale: Basic Pay of Rs.56,100/- and other allowances as admissible under the rules.

2. ELIGIBILITY CRITERIA FOR THE POST OF SENIOR RESIDENTS -

A. Qualification:-

- (1). MBBS with Post Graduate Degree/ DNB/ Diploma or equivalent as per residency scheme in concerned specialty from a recognized University/ Institution.
- (2). In the condition, if candidates having P.G. degree/DNB/Diploma are not available, those without P.G. qualification but having 02 year's experience in concerned specialty may be considered on adhoc basis (till the PG or regular candidate joins, whichever is earlier).
- B. Age: Below 45 years, On Date of Interview, as per order No.F.DHF&W/Q015/57/2016-HR-Medical-secy(H&FW)/CDNo.112425062/1502-08 dated 26.11.2020. Age limit is relaxable by 05 year for SC/ST candidates.
- C. <u>Pay:</u>- Basic of RS. 67700/- in pay Matrix 11 of 7th CPC with other allowances as admissible per month.
- D. The candidate must have completed internship & must be registered with Delhi Medical Council.
- E. OBC candidates are required to submit their caste certificate (issued before the date of application) issued by the Govt. of NCT of Delhi along with the Non Creamy Layer certificate of current financial year.
- F. Appointment will be initially for a period of 89 days or till the recruitment of Senior Resident on Regular Basis or till PG candidate joins (in case of Non PG candidate), whichever is earlier.

- G. Appointment will be subject to medical fitness and verification of certificate of educational qualification/age/caste/DMC registration and internship completion certificate etc.
- H. Candidate must not have completed three year senior residency from any Govt. Hospital. (*)
 - (*)Further in case of non-availability of candidates, as per the relevant scheme mentioned above, candidates may be considered in terms of relaxation of provision as per circular No. F.No.121/26/2010/H&FW/1996-2045, dated 10.06.2011 issued by Health & Family Welfare Department, Govt. of NCT of Delhi with the following relaxation.
 - 1. In the Specialties where no fresh candidates are available, candidates, who have completed 3 years of Sr. Residency, may also be allowed to appear in the interview.
 - 2. Separate merit list would be prepared for the candidates who have completed their residency of 3 years as SR.
 - 3. Firstly the list containing name of fresh candidates would be exhausted for appointment as SR and the second would be used only after that.
 - 4. Further, all senior Resident appointment from second list will be for one year only for those who have already completed 3 years of Residency. It would not be renewable after one year. Senior Resident may be assigned duties in Emergency Department as & when required in case of any exigency.

I. CONDITION FOR RECRUITMENT -

- A. All the eligible candidates should report in the office of the undersigned at 9.30 A.M. [Time for enrollment from 9.30 A.M. to 11 A.M. only] on the day of interview.
- B For candidates applying for OBC category, the certificate must be issued by the competent authority of Govt. of NCT of Delhi. Persons with disabilities shall be given relaxation as per rule.
- C The number of vacancies may vary.
- D No TA/DA will be given for appearing in the interview.
- E Candidate must submit their Bio-Data with attested photo copy of certificates and original documents should be shown at the time of interview.
- F Candidates are advised to ensure that they fulfill the eligibility criteria as mentioned in the advertisement before appearing in the interview.
- G Other services conditions will be applicable as per service condition prescribed from time to time by the Govt. of NCT of Delhi.
