- L. Qualification; MBBS degree from a recognized University. Valid registration with Delhi Medical Council. Must not have completed one year Junior Residency in any recognized institution including regular & adhoc period.
- 2. Internship: The candidate should have completed compulsory rotating internship after 21.11.2022, this relaxation is in view of upcoming post graduate NEET exam and acute shortage of JRs in current scenario.
