ELIGIBILITY for Senior Residents:-

- Qualification:-** For Senior Resident (Accident and Emergency) Post Graduate Degree MD/MS/DNB/DIPLOMA recognized by MCI, MD (Emergency Medicine), MD (Medicine), MD (Anaesthesia), MS (Surgery), MS (Ortho). In Case of non availability of MD/MS/DNB/DIPLOMA candidates in the above mentioned specialties, candidates who have at least 02 years experience in a Government Hospital in Emergency Medicine/Casualty/ Medicine/Intensive care unit (Anaesthesia)/Surgery/Ortho will be considered for the post and will be appointed on purely Adhoc basis for 89 days or till joining the Specialist.
- Scope of work for Senior Resident (Accident and Emergency):** Would include Emergency Management of cases presenting in Casualty including Medico-Legal cases. Proper documentation of MLCS. Timely referral of cases requiring specialized care to higher center Supervision of Residents and staff posted in Casualty.
- Age Limit For SR.** -45 years for General, 50 years for SC/ST and 48 years for OBC (Delhi) Candidates (as on date of interview), as per order F.No. DEF&W/Q015/57/2016-HR-Medical Secy.(H&FW)CD No. #11245062/1502-08 Dated 26/11/2020.
- DMC Registration:** Candidates must have valid DMC Registration with PG Degree/ Diploma.
- The appointment and services will be governed under Residency scheme of Govt. of India.
- Basic of Rs 67700/- in Revised Pay Matrix 11 of 7th CPC & other allowances as admissible.
- No separate letter for interview will be issued. No TA/DA will be paid for appearing in interview.
- Candidates must bring Original Certificates & submit their Application along with self attested copies certificate at the time of interview.

9. All appointment shall be subject to medical fitness by the Staff Physician of MVH and verification of certificate of educational qualification/age/caste/submission of valid DMC registration certificate and internship completion certificate etc.

The candidates who have completed three years Senior Residency but are willing to serve as Senior Resident can also apply and will be offered residency only if no fresh Senior Residents are available. However, their appointment will be for a period of 89 days extendable up to a maximum period of one year only.
11. Waiting list will be prepared if any, will be valid till next interview or till six months from declaration of results whichever is earlier.
12. Selected candidates shall be allowed to join within 07 working days from the issue of the offer letter failing which the offer shall stand automatically cancelled. No extension for joining will be considered.
13. In case of any inadvertent error detected at later stage the same will be rectified according to rules.
14. The Competent Authority reserves the right of any amendment or cancellation of the advertisement.
15. The Competent Authority reserves the right to decide in case of any dispute with regard to selection process.
