


CONDITION FOR RECRUITMEN:


- A. All the eligible candidates should report in the office of the undersigned at 9.30 A.M (time for enrollment from 9.30 A.M to 10.30 A.M only) on the day of interview.
- B. For candidate applying for OBC category the certificate must be issued by the Competent Authority of Govt. of NCT of Delhi. The OBC candidate must be in possession of non-creamy layer certificate for current year.
- C. Persons with disabilities shall be given relaxation as per rule.
- D. The number of vacancies may vary.
- E. No TA/DA will be given for appearing in the interview.
- F. Candidate must submit their Bio Data with attested photocopy of certificates and original documents should be shown at the time of interview.
- G. Candidates are advised to ensure that they fulfill the eligibility criteria as mentioned in the advertisement before appearing the interview.
- H. Other service conditions will be applicable as per service conditions prescribed from time-to-time by the Govt. of NCT of Delhi.

In case no candidate with above qualification then 02 years post MBBS experience with 01 year experience in concerned speciality will also be considered. Candidate must be enrolled with Delhi Medical Council. Candidate must not have completed 03 years SR in any Hospital under state Govt./Govt. of India including Regular or Adhoc Period
