Date & time of Interview:- 07.08.2024 at 11.00 A.M onward on the mentioned date, Candidates must report on time so that there is no delay in interview.

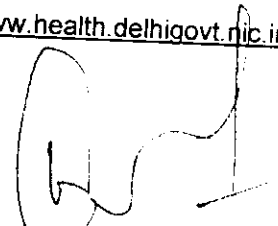
CONDITION FOR RECRUITMENT:-

- M. In case of non-availability of reserve candidate, seat will be open for all.

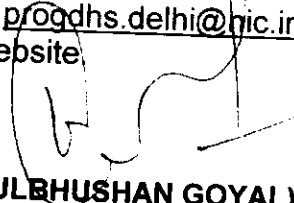
