TENURE:- The Tenure of Senior Resident is for period of three years including any service rendered as Senior Residen earlier on adhoc/regular basis in recognized institution. - 10. For Persons with disabilities (Divyangjan) candidate relaxation is admissible as per Govt. of India rules upon submission of Handicapped Certificate from the competent authority;

- 12. All SR already working on ad-hoc basis in SDDMASC need to apply and appear in the interview afresh.
