Only those Candidates may appear for the interview who fulfill the eligibility criteria as per Residency scheme of the GOI and the qualification/eligibility criteria as follows:-

Submission of application:- Applicants must bring following original documents along with one set self attested copies on date of interview without which they will not be allowed for interview/test.

- 1. Application in prescribed format with 2 passport size photograph.
- 2. 10th Class certificate showing date of Birth, Resident Proof/Adhar Card/ PAN Card.
- 3. MBBS/Internship/MD/DNB/Diploma certificates.
- 4. Post MBBS/Post PG DMC certificate.
- 5. Cast certificate/EWS certificate (if applicable), Non Creamy layer certificate, in case of Delhi OBC.
- 6. Experience certificate, if any.

QUALIFICATIONS:- MBBS with post graduate Degree/Diploma/DNB in the concerned specialty from a recognized University/Institution and should have a valid registration with Delhi-Medical Council and the candidate must not have completed 03 years Senior Residency in any recognized institution including regular and adhoc period. In case of non availability of PG candidates, minimum 02 years experience in concerned specialty may be considered as per residency scheme. However such candidates will be appointed on adhoc basis for 89 days extendable upto 03 years or till the candidate with PG degree/diploma/DNB are available, whichever is earlier.

<u>AGE</u>: 45 years for General (5 years Relax-able for SC/ST, 03 years relax-able for OBC and 05 years extra relax-able for Persons with disabilities (Divyangian) candidate 1 as on date of interview.

Pay Scale: - As per Pay Matrix of Level 11 (Rs. 67700-208700) other usual allowances as admissible under the rules.

<u>TENURE:</u> The Tenure of Senior Resident is for period of 89 days extended upto three years including any service rendered as Senior Resident earlier on adhoc/regular basis in recognized institution. The appointment will be initially for a period of 89 days on adhoc basis that can be extendable upto 03 years subject to satisfactory performance work & conduct report from concerned Incharge and vigilance clearance.

Note: The candidates selected on adhoc basis against the reserved seat will be appointed for a period of 89 days extendable upto a maximum period of 03 years or till the regular/Adhoc reserved candidate joins whichever is earlier.

In case of non availability of fresh candidates, as per the relevant scheme, candidates may be considered in terms of relaxation of provision as per circular no. F121/26/2010/H&FW/1996-2045 dated 10.06.2011 of Department of H& FW, GNCTD of Delhi with the following relaxation:-

- 1. In case of non availability of fresh candidates, the candidates who have completed 03 years of Senior Residency may also be allowed to appear in the interview.
- 2. Separate merit list would be prepared for the candidates who have completed their residency of 03 years.

- 3. Firstly the list containing the names of the fresh candidates would be exhausted for the appointment and the second list would be used only after that.
- 4. All appointment of residents from the second list will be for 01 years only; it would not be renewable after one year.

Note: All the appointment under enabling criteria will be done for a period of 89 days extendable maximum upto 01 year or till the availability of regular/Adhoc fresh eligible candidate of same category whichever is earlier.

Other conditions and requirement :-

- 1. 4% seats shall be reserved for physically handicapped persons as per rules.
- 2. Number of vacancies is provisional and subject to change without any notice.
- 3. For appointment against posts reserved for OBC only candidates having the OBC certificate issued by the competent authority of GNCT of Delhi shall be eligible. Outside Delhi OBC candidates will be treated in UR (General category). The OBC candidates must be in possession of non-cremy layer certificate along with his / her caste certificate on or before the date of interview.
- 4. For SC/STs; relevant certificate issued from the judicial revenue authorities as per O.M. NO. 36012/6/88-Estt. (SCT), (SRD, III) Dated 24/04/1990 by the GOI Department of Per. & Trg. Shall be accepted.
- 5. Economically Weaker Section (EWS); Persons who are not covered under the scheme of reservation for SC's, ST's and OBC's and whose family has gross annual income below RS. 8 Lakhs are to be identified as EWS's for benefit of reservation. Income shall also include income from all sources I.e. salary, agriculture, business profession etc. For the financial year prior to the year of application. Such candidates should have valid income certificate on the date of application in the prescribed format or on the letter hear of the issuing authority to this effect before filling the application and submit the same at the time of document verification, failing which their candidature will be rejected, for more information, please download office memorandum no.36039/1/2019-Estt (Res), dated 31/01/2019 from ministry of Personnel, Public Grievances & Pensions, Department of Personnel & Training.
- 6. For Persons with disabilities (Divyangjan) candidate relaxation is admissible as per Govt. of India rules upon submission of Handicapped Certificate from the competent authority;
- 7. Candidates who wish to apply against EWS category are required to submit the said EWS certificate issued by the Competent Authority in prescribed format as notified vide Office Memorandum no. 36039/1/2019-Estt (Res), dated 31/01/2019.
- 8. The services of SR will be governed by residency schemes of Govt. Of India Civil service (Temporary Rules).
- 9. Candidates are required to bring all original certificate and testimonials along with two recent passport size photographs on the date of interview.
- 10. Mode of selection will be through interview only.
- 11. Waiting list will be prepared if any, will be valid till next interview or till 3 (Three) months from declaration of result whichever is earlier.
- 12. Selected candidates shall be allowed to join within 3 working days from the issue of the offer letter failing which the offer shall stand automatically cancelled. No extension for joining will be considered.
- 13. Appointment shall be subject to medical fitness and verification of certificates.
- 14. No separate call letters shall be sent and no TA/DA shall be admissible for attending interview.

Interested candidates may report for registration at 09:30 AM till 11:30 AM in Admin branch 2nd floor along with above mentioned documents. Only those candidates whose registration is completed by 11:30 AM shall be eligible fro appearing before interview board. The interviews will be held thereafter. All original certificate must be brought for verification.
