WALK IN INTERVIEW

A Walk-in interview is scheduled to be held for the appointment of **SENIOR RESIDENT** Doctors under Residency Scheme in this hospital as per the details given below. The appointment will be on **ADHOC BASIS** for a period of 89 days or till the recruitment of Senior Resident on Regular Basis, whichever is earlier. Interview of eligible candidates will be held on daily basis as mentioned below in **Conference Hall, 2nd floor, Administration Block, SVBP Hospital.**

1. VACANT POST -

* In case of non-availability of category candidates, seats shall be open for all.

2. ELIGIBILITY CRITERIA FOR THE POST OF SENIOR RESIDENTS

A. Qualification:-

- (1). MBBS with Post Graduate Degree/ DNB/ Diploma or equivalent as per residency scheme in concerned specialty from a recognized University/ Institution.
- (2) **For SR (Medicine) only** - If candidates having PG Degree/Diploma (in Medicine) are not available, those with PG (Chest/Emergency Medicine/ Geriatric Medicine / Family Medicine) may be considered.

Further if the mentioned eligibility candidates are not available, those with 03 years' experience of MD/DNB (in Medicine) and either waiting for result or appearing in MD/DNB (in Medicine) exam may also be considered.

B. Age :- Below 45 years, **On Date of Interview**, as per order No.F.DHF&W/Q015/57/2016-HR-Medical-secy(H&FW)/CDNo.112425062/1502-08 dated 26.11.2020. Age limit is relaxable by 05 year for SC/ST candidates.

C. Pay:- Basic of RS. 67700/- in pay Matrix 11 of 7th CPC with other allowances as admissible per month.

D. The candidate must have completed internship.

E. Must be registered with Delhi Medical Council.

F. Appointment will be initially for a period of 89 days or till regular joins, whichever is earlier and may be extended beyond 89 days maximum upto 03 years on the same conditions based on work and conduct report.

G. Appointment will be subject to medical fitness and verification of certificate of educational qualification/age/caste/DMC registration and internship completion certificate etc.

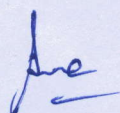
H. Candidate must not have completed three year senior residency from any Govt.Hospital.(*).

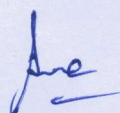
