- **1.** MBBS with Post Graduate degree/DNB/Diploma as per Residency Scheme in concerned specialty from MCI recognized University.
- 2. The candidate must have completed internship and registered with Delhi Medical Council with Post Graduate degree/ Diploma and have not completed 3 years Senior Residency in any recognized institution either on regular or adhoc basis.
- 3. In the condition, if candidates having Post Graduate Degree/DNB/Diploma are not available, those without Post Graduate qualification but having 02 years experience in concerned specialty may be considered.
- **4.** Age: Up to 40 years for General category, 5 years relaxable for SC/ST and 03 years for OBC candidates (belonging to Delhi only) on the closing date of submission of application. Further upper age limit for persons with disabilities shall be relaxable by 10 years.

Conditions of Recruitment:

- 1. Appointment will be initially up to 30.06.2016 only or till Regular candidates joins whichever, is earlier.
- 2. Appointment shall be subject to Medical Fitness and Verification of certificates of educational Qualifications/Age/Caste/DMC registration and internship completion certificate.
